APPARENT CONSUMPTION OF INDUSTRIAL EXPLOSIVES AND BLASTING AGENTS IN THE UNITED STATES, 1977

Apparent consumption of explosives and blasting agents in the United States increased 11.4% to 3.7 billion pounds, according to the Bureau of Mines, U.S. Department of the Interior. Apparent consumption is measured by sales reported by manufacturers.

Consumption rose 15.1% for bulk blasting agents (other processed blasting agents and unprocessed ammonium nitrate) and cylindrically packaged blasting agents added together. The reason for consideration of these two classifications as one is explained on page 2, paragraph 4. Use of water gels and slurries declined 6.5%, permissible explosives rose 9.5%, and other high explosives declined 7.2%.

All users except the metal mining industry consumed greater quantities in 1977 than in 1976. More than half (56.4%) of the total weight of explosives and blasting agents was used in coal mining, which consumed 95.4% of permissible explosives, and 62.5% of cylindrically packaged blasting agents and bulk blasting agents combined. Other high explosives were consumed principally in quarrying (33.9%) and construction (27.6%). The major use of water gels and slurries was in metal mining (48.8%).

Seven States collectively consumed 58.8% of all explosives and blasting agents used in the United States in 1977. These were, in order of consumption, Kentucky, Pennsylvania, Alabama, Ohio, West Virginia, Virginia, and Arizona.

Classification of Industrial Explosives and Blasting Agents

"Apparent consumption" of explosives and blasting agents, as used in this report, means sales reported by manufacturers of such to the Bureau of Mines on Form 6-1439-A, plus sales reported to the Institute of Makers of Explosives (IME) by IME members and provided to the Bureau on a confidential basis. Classification of any particular quantity of explosives (or blasting agents) by type and use appears as reported by the manufacturers. Coverage is substantially complete, but occasional omissions do occur, and the Bureau would welcome notification of them. In particular, any sales of explosives (or blasting agents) imported by nonmanufacturers of explosives (or blasting agents) are not included; these may be locally important. Another unavoidable inaccuracy is caused by the necessity to conceal certain figures to protect company confidentiality.

The main distinction between explosives and blasting agents is related to their safety in handling. Formerly explosives were classified as those materials that were cap-sensitive, and blasting agents were classified as materials requiring a primer. This distinction remains the principal criterion. Only "high" explosives are currently used in industry; "low" explosives (which decompose more slowly than high explosives) included principally black powder, which has not been reported in industrial use since 1971. Explosives vary widely in composition, whereas blasting agents are essentially ammonium nitrate plus a fuel.

Water gel and slurries may be either explosives or blasting agents, but for convenience are classified separately in a recognizable category.

Previously the five product classifications used in this report were the same as those adopted by the Institute of Makers of Explosives (IME); however in 1977 the IME reclassified two categories by expanding number 4, Cylindrically Packaged Blasting Agents, to include Other Processed Blasting Agents, which was formerly part of number 5. IME's number 5 now includes only Unprocessed Ammonium Nitrate. Because the IME reporting of these two classifications to the Bureau differed from the reporting of nonmember companies to the Bureau, the 1977 data are not comparable to prior years. Total quantities derived from combining number 4 and number 5 are essentially accurate. The Bureau of Mines classifications follow:

1. Permissibles.--Grades of high explosives approved by brand name by the U.S. Bureau of Mines or the Mine Safety and Health Administration for use, in a prescribed manner, in underground coal mines.
2. Other High Explosives.--All high explosives EXCEPT
 - a) permisibles and
 - b) any water gels or slurries that would otherwise be classified as high explosives

Included in the "Other High Explosives" classification are all formulations packaged in metal containers.

3. Packaged and Bulk Water Gels and Slurries.--All water gels and slurries, packaged or in bulk, made by addition of more than 5% water to high explosives or blasting agents.

4. Cylindrically Packaged Blasting Agents.--Ammonium nitrate and fuel mixtures packaged in paper, burlap, or plastic containers of cylindrical shape, labeled with trade name identification plus diameter and weight or length measurement. The purpose of this classification is to distinguish "down-the-hole" materials from bagged blasting agents for bulk loading.

5. Other Processed Blasting Agents and Unprocessed Ammonium Nitrate--

- a) Ammonium nitrate and fuel mixtures sold in bulk or packaged in paper, plastic or burlap bags, or other containers designed for bulk loading, and
- b) Prilled or grained ammonium nitrate for explosives use.
